6.2.3 Annual Analysis of Use of Force Reporting

1. Purpose:

The purpose of this policy section is to establish the completion of the Annual Analysis of Use of Force Reporting.

2. Policy:

The Sheriff, or designee, shall prepare an annual analysis report on use of force incidents. If completed by someone other than the Sheriff, the report will be submitted to the Sheriff for review. The report shall not contain the names of officers, suspects, or case numbers and shall minimally include:

- A. Day and time each incident occurred; (KLEAP 6.2.3 a)
- B. Types of incidents resulting in the use of force; (KLEAP 6.2.3 b)
- C. Trends or patterns related to race, age, gender, reason for initial response, and location of subjects involved; (KLEAP 6.2.3 c)
- D. Trends or patterns of injuries to any subjects or agency members involved; and (KLEAP 6.2.3 d)
- E. Any influence of findings on policies, procedures, training, and equipment. (KLEAP 6.2.3 e)



An in-depth analysis of uses of force is intended to identify patterns or trends that could indicate needs or modification to existing training, equipment, and/or policy and procedures that will result in safer interactions between community members and officers. The process of collecting and reviewing use of force reports is also critical to this analysis.

In accordance with accreditation standards and Marshall County Sheriff's Office policy a written report is completed when an employee: discharges a firearm (other than routine training, euthanizing an animal, or for recreation purposes), takes any action resulting in, or alledgedly results in, injury or death of another person, applies force through the use of less-lethal or lethal weapon(s), or applies weaponless physical force at a level defined by the Marshall County Sheriff's Office.

Use of Force Occurrences by Number of Incidents per Year



The use of force in the business area was an agency assist, where an intoxicated subject was being disorderly at the local bowling alley in Marysville and needed to be removed. The Deputy was assisting the Marysville Police Department with the matter. After removing the subject and having him return to his Motel room directly across the parking lot, the subject made several aggressive movements towards the Marysville Police Officer. He was pushed back and told he was under arrest. The subject was ordered to place his hands behind his back and would not do so. After several attempts at trying to take physical control of the subjects' arms, the Deputy gave verbal warning to the subject that he would be tased if he did not comply with the order. The subject still refused, so the Deputy removed the cartridge from his taser and delivered a single 5 second drive stun to the subject. They were able to secure one arm but the subject continued to fight and the Deputy delivered a second 5 second cycle of the drive stun mode. The second arm was then able to be secured and the subject was taken into custody. The use of force in the rural area was a call for service to a rural road for suspicous activity. Upon arrival to the area, the responding Deputy called for backup as one of the subjects fled from the area. After the arrival by the second Deputy the subject was located and upon ordering the subject to place his hands behind his back, the subject resisted and pulled away from the Deputy stating "no". A physical encounter with the subject and the two Deputies ensued and after multiple orders to give up his hands, the subject still refused. After giving warning of being tased, the second responding Deputy delivered a single 5 second drive stun to the subject and compliance was achieved. The subject was taken into custody without any further incidents. No pattern's or trends were were noticed.






