MY BACKGROUND

I started like many in law enforcement—wanting to help my community. Over 26 years, I served in Patrol, Sex Crimes, and Homicide, and spent a decade as a Crisis Negotiator. I led Investigations at a large municipal agency, overseeing major cases, including homicides and officer-involved incidents with exceptionally high clearance rates for fatal and non-fatal shootings.

*After conducting thousands of interviews, I've learned that outstanding policing comes down to one thing: **effective information gathering**. That's what this class is about.*

I hold degrees in Criminology and Forensic Psychology and serve as a National Institute of Justice LEADS Scholar, Executive Fellow with the National Policing Institute, and Co-Director of Project Aletheia at John Jay College.
